

**TERMS AND CONDITIONS
OF USE OF THE PREMISES OF THE UNIVERSITY OF OPOLE FOR
THE PURPOSE OF TEMPORARY PARKING OF MOTOR VEHICLES**

Section 1

1. These terms and conditions set out the rules for using the grounds of the University of Opole for the purpose of parking motor vehicles.
2. The University of Opole premises may be used for the purposes specified in subsection 1 by employees, students and doctoral students of the University of Opole, lessees of commercial premises at the University of Opole, and other natural persons, hereinafter referred to as Users.
3. Depending on the type of system used in a given location, a remote control for the barrier or a contactless card shall provide access to the premises of the University of Opole for the purpose of leaving a motor vehicle there.
4. Remote controls or contactless cards for the barriers issued to Users are the property of the University of Opole, and each User is entitled to one remote control or one contactless card.
5. If an access control system based on vehicle registration number recognition is used, the User will receive a remote control for the barrier or a contactless card, and the User's street number will be included in the access control system.
6. The grounds specified in subsection 1 are the property of the University of Opole, which manages these grounds.

Section 2

1. The grounds of the University of Opole listed in Section 1, intended for the purposes specified in Section 1(1) are unguarded, accessible every day of the year, 24 hours a day, whereby the University of Opole has the right to restrict the right of Users to use the said premises for a specified or indefinite period of time, without having to provide any justification.
2. The grounds of the University of Opole are designated for the temporary parking of vehicles with a maximum gross weight not exceeding 3.5 tonnes.

Section 3

1. By entering the premises of the University of Opole, the User agrees to these Terms and Conditions and undertakes to strictly comply with their provisions.
2. The following are prohibited on the premises of the University of Opole:
 - a) leaving vehicles on pavements, roadsides, emergency routes, fire lanes and other restricted areas,
 - b) leaving motor vehicles other than those specified in Section 2(3),

- c) repairing and washing vehicles, cleaning their interiors, and draining and replacing coolants, fuel and oil,
 - d) leaving vehicles in spaces designated for disabled persons without the appropriate document (disabled parking permit) – in order to prevent unauthorised persons from using parking spaces reserved for disabled persons.
3. Users are obliged to maintain order and cleanliness on the premises of the University of Opole, dispose of all trash in waste bins, and park and stop their vehicles in an orderly manner.
 4. Failure to comply with these Terms and Conditions shall constitute grounds for towing the vehicle away at the User's expense and for terminating the contract without notice.

Section 4

The University of Opole and the User shall conclude a contract on the use of the University of Opole premises, – in accordance with the template attached to these Terms and Conditions.

Section 5

1. A remote control, contactless card or vehicle registration number included in the electronic access control system authorises motor vehicles to enter the premises of the University of Opole.

3. The User shall pay an annual fee in advance for the use of the premises of the University of Opole for the temporary parking of motor vehicles, in the amount and at the regularity specified by the Chancellor of the University of Opole. In the event of failure to pay the fee, the UO reserves the right to deactivate the remote control/contactless card/vehicle registration number included in the electronic barrier access control system.
4. The University of Opole does not guarantee the availability of free parking spaces on the University of Opole premises.
5. The number of cards available to students and doctoral students of the University of Opole is determined by a decision of the Chancellor of the University of Opole.

Section 6

1. The University of Opole reserves the right to verify the use of remote controls, contactless cards and vehicle registration numbers included in the electronic barrier access control system.
2. The issuance of a remote control or contactless card, as well as the addition of a vehicle registration number in the electronic barrier access control system and the activation of access, is carried out by the Infrastructure Office after payment of the fee specified in Section 5(3).

Section 7

1. Should you lose your remote control or contactless card for the barrier, you may apply for a new card or remote control after paying the fee specified in Section 5(3).

2. In the case of using an access control system that verifies the registration numbers of vehicles entering the premises of the University of Opole, changes to the number assigned to the User are made by an employee of the Infrastructure Office.

Section 8

1. Users leave their vehicles on the premises of the University of Opole at their own risk, and the University of Opole reserves the right not to be held liable for any loss or damage to the vehicle or any property left inside it.
2. The User shall be liable for any damage caused by the vehicle on the premises of the University of Opole.
